Give permission for your child to attend school outings within the general locality.

Media (Photographs)

Agree for your child's attendance at media events.

Agree for your child's work being published on the school's website.

Agree to the release of your child's information for school photos.

Give consent for photographs and video recordings of your child being taken and used by the school or Catholic Education Archdiocese of Canberra & Goulburn websites, social media, Catholic Voice and other publications online and in print.
